## Trinidad and Tobago Onshore and Nearshore Competitive Bid Round 2022

## Procedure for obtaining a Data Package

- 1. Download the Data Use Agreement from the Ministry's website. Complete two (2) originals of the Data Use Agreement and submit to the Ministry. We will accept a scanned copy of the signed original.
- 2. Payment of the bid fee of USD 30,000.00 or the equivalent in the currency of Trinidad and Tobago, using the Daily Exchange Rate specified by the Central Bank of Trinidad and Tobago on the date of the payment, must be made through *either of* the following means before the data package is available for download:
  - *i.* Payment in the currency of the United States of America can be effected by a deposit to the Federal Reserve Bank, U.S.A., using the information provided in the table below, and stating the reason for the payment as "Bid Application Fee for Trinidad and Tobago Onshore and Nearshore Competitive Bid Round 2022".

- 3. Once payment is received, data packages would be delivered via Box.
  - (i) If you do not have a Box account, a free account can be created using https://account.box.com/signup/n/personal#3usc7.
  - (ii) Ensure that the device has sufficient space to accept the zipped files. File size is estimated at 410 GB. Note: the zipped files can then be transferred, if required, to another disk with appropriate space to be unzipped.
  - (iii) The zipped files should be downloaded in groups of ten (10) files or less at a time, as Box has a file size limit for downloads.
  - (iv) Once all data are downloaded, you will require 7zip software to unzip files. If 7zip is not installed on your device, you can download a free copy from <a href="Download (7-zip.org">Download (7-zip.org)</a>
