## JOB TITLE: PETROLEUM OPERATIONS DIRECTOR

#### JOB SUMMARY

The Petroleum Operations Director is responsible for providing the leadership and vision necessary to regulate and manage all energy based facilities that operate in Trinidad and Tobago to ensure the following by: protecting people, property and the environment from risks generated from energy based operations; safeguarding the State against liabilities associated with accident related downtime, pollution and accidents; ensure that the State derives a fair and equitable return on produced energy resources; ensure that end consumers get the correct value for retail products purchased.

#### DUTIES AND RESPONSIBILITIES

- Plan, organize and direct the work of the Petroleum Operations Monitoring Division.
- Direct investigations of major incidents and accidents in the Energy Sector,
- Direct investigations of complaints from the public related to Energy Sector operations.
- Design and/or approve systems and programmes to ensure correct assessments in the fiscalisation of crude oil and natural gas.
- Lead periodic meetings and discussions with Energy Sector companies and Government Ministries and agencies related to Energy Sector operations.
- Manage the collaboration between the MEEI and other regulatory agencies such as the Environmental Management Authority, Occupational Safety and Health Agency, Town and Country Planning, organize and direct the work of the Petroleum Operations Monitoring Division.
- Direct investigations of major incidents and accidents in the Energy Sector,
- Direct investigations of complaints from the public related to Energy Sector operations.
- Design and/or approve systems and programmes to ensure correct assessments in the fiscalisation of crude oil and natural gas.
- Manage the collaboration between the MEEI and other regulatory agencies such as the Environmental Management Authority, Occupational Safety and Health Agency, Town and Country Planning Division, Trinidad and Tobago Fire Services on matters related to Energy Sector operations.
- Monitor and evaluate research and development of new regulatory instruments inclusive of upgrades to existing regulatory regime.
- Direct and manage the Ministry's Emergency Response Plans for the Energy Sector.

- Direct the development of training for staff inclusive of a training plan and mentorship programmes.
- Direct the formulation, review and maintenance of polices for the energy sector.
- Direct the Asset Integrity Management System for the Energy Sector.
- Lead in the prevention of the State from incurring Health, Safety & Environment (HSE) or Operational liabilities.
- Direct the Incident Management System for emergency response activities in the Energy Sector.
- Direct the review of EIAs and Risk Assessment Reports.
- Direct the analysis and compilation of HSE and Operational data.
- Direct research and development projects on HSE and Operational Matters.
  Participate in stakeholder and cross functional team activities to maintain
- stakeholder relations, interactions and communications.
- Direct abandonment and decommissioning programmes.
- Direct the management of chemicals approved for use in the Energy Sector.
- Direct the monitoring programme for HSE and operational data.
- Direct the MEEI review of Environmental Impact Assessments and Risk Assessments submissions.
- Direct the coordination of emergency response preparedness, crisis management and disaster recovery programmes and business continuity programmes in the Energy Sector.
- Direct the preparation and screening of reports, technical papers, speeches and presentations.
- Represent the Ministry on relevant internal and external committees.
- Represent the Ministry's interest amongst relevant government ministries and agencies when required.
